Croghan Fire Dept.: Steve Monnat and Warren Shaw came to give a short presentation on the calls they responded to in the Township. They responded to 6 calls, 2 were ATV accidents, 1 involved a boat, and in 2 years they only had 1 fire call. Their budget is about \$141,000, expenses are about \$130,000. They do one fundraiser a year, participate in coldwater rescue, do have trained EMT's.

Lowville Fire Dept: Joe Austin, Fire Chief, along with his Assistant Chiefs, Jerry Nortz, and Anthony Martin gave a short video presentation of training someone needs to go through to become a Volunteer Fireman. Discussed their services, they have recently purchased battery operated jaws of life. For the year 2021 - responded to a total of 214 Fire calls - 55 of which were in the Town. Also, had number of other calls that they responded to in the Township, Have worked with Highway Superintendent, Steve Skiff with our water system, and want to do so again in the spring to determine usage in case of a structure fire, and if tankers will be needed also.

The Board thanked both Departments for coming and giving a presentation.

Tom Turck was given the floor, to pass pictures of his tub, sink and shower curtain and the discoloration since being on the Watson Water as well as being broke out and itchy. He stated he unhooked the Watson Water and went back to his well water for a few weeks, recommended by his Dr. Discussion followed, and Mr. Turck will come to the February meeting to discuss if he is better, and what if anything can be done.

Scott Lawrence, CPA was given the floor. Needs some paperwork for the AUD report. Chris & Mike will work together to get the these items to him. Discussed an hourly wage for Data Collector, Court Clerk, and Deputy Clerk.

Regarding some of the Organization Items, it was decided to do this at the next meeting when the new Council Member will be present.

Highway Report: superintendent Skiff reported that the Truck should be beginning to be built tomorrow, January 13, 2022, then will be sent to Viking. His office floor and painting came to about \$1,100, less than quoted. Would like to do the lunchroom also. There was a water leak for approximately a week, losing 25,00 -35,000 gallons per day, found the source of the leak, and shut the water off at the curb stop. Resident had shut valve off under trailer, froze and when it thawed, the pipe was broken. Resident doesn't currently live there. Waiting for paperwork from the County regarding the Bridge repair, should have that by next meeting.

Town Justice: Justice Regetz discussed his year-end report. Asked if any questions. Also, he explained that the December Monthly Report was incomplete as there is a deposit missing. He has spoken to the Justice Dept., and is working to resolve this matter.
