Can get on the County System, we have to purchase our own radios, he has a quote from Castner Communications for \$37,551.96 (State Contract Price) which includes a base for the garage, 12 vehicle radios and portables. We can also have 2 lines dedicated to the Town of Watson. Discussion followed.

IMA (Intermunicipal Agreement) with the County, gives the County all responsibility of designing the

Wilson Bridge in 2022 & Construction in 2023. Supervisor Hoch stated he sent the Agreement to Ray Meier to review.
