Local Law 2 of 2019

A Local Law Extending a Moratorium on Establishing or Expanding Campgrounds

**BE IT ENACTED BY THE TOWN BOARD OF THE TOWN OF WATSON AS
FOLLOWS:**

Section 1. Title

This Local Law shall be known as the "Local Law Extending the Moratorium on Establishing or Expanding Campgrounds in the Town of Watson:

Section 2. Purpose and Intent.

The Town of Watson previously enacted by Local Law a moratorium on establishing or expanding campgrounds in the Town of Watson for a period of one year. During this one year period, the Planning Board has been working with the Town Board to review the matter and has now completed a draft of proposed campground regulations. The Town Board will now require some time to review, possibly make revisions, and to provide for such other and further reviews as may be required by law or as the Town Board may find to be advisable.

Section 3. Terms of this Local Law.

The existing moratorium on establishing or expanding campgrounds in the Town of Watson is extended for a period of three months from the expiration of the current moratorium which will occur on or about December 19, 2019. During such period of extension, no person, firm, corporation or other entity shall place, construct, or expand a campground as such term is defined by Section 1020 of the Town of Watson Zoning Law. During the period of such extension, no town officer, official, board or agency shall issue any permit or other approval for establishing or expanding a campground.

Section 4. Effective Date

This Local Law shall take effect immediately upon filing in the Office of the New York State Secretary of State.
