Local Law Number 3 of the Town of Watson for 2021

Be it enacted by the Town Board of the Town of Watson.

Title: This Local Law shall be known as "A Local Law amending Local Law Number 1 of 2019.

A Local Law establishing (Water Rules and Regulations) With Regard to Fees and Charges within Extension One to Water District Four in the Town of Watson."

Text: The Section of Local Law Number One of 2019 entitled "Times and Payment, Interest and Penalties" and specifically:

Paragraphs A thereof shall be amended so that such paragraph A shall now read as follows:

A. The unpaid portions of bills are added to the tax rolls of the Town on the first day of November of each year for collection.

Paragraph B thereof shall be amended so that such paragraph B shall now read as follows:

B. Any customer, new or otherwise, taking water for a part of any three-month period will be charged the minimum charge for that period together with any excess usage for that period if used. With regard to customers within Extension One of Water District Four, who have had a lateral and related equipment installed, they shall be required to pay the minimum quarterly usage charge as provided for in the Fee Schedule and an Operation and Maintenance Fee regardless of whether such customer uses water from the system or not. If a customer uses water in amounts in excess of the minimum usage such customer shall be charged for such excess as provided for in the Fee Schedule. The Fee Schedule of the Town of Watson applies and charges shall be made to customers within Extension One to District Four regardless of whether their lateral was installed as part of the Extension One District Four Project or or by private arrangement made by the customer.

Effective Date: This Local Law shall take effect upon filing with the New York State Secretary of State.
