<u>New Business:</u> Town of Watson Park Use application brought to the board. It was approved that any person/persons reserving the park sign the agreement/application prior to use. The user would return signed application when deposit is dropped off with the clerk. This will come into effect as of now for anyone reserving from here on.

Discussion about offering a pool fill service to those in the Town of Watson, as there is now municipal water here. Further information will be gathered on this in regards to a hydrant meter or a fill station at the Town Barn. Motion made to table this made by Vicki Roy and seconded by Jeff Lyng.

Discussion about an emergency dog contract between the town and Countryside Veterinary Clinic. This contract would put a dollar amount on the bill the Town is willing to cover if a dog had to be taken for an emergency visit to the clinic and the owner could not be found/contacted. Further details to follow.

Discussion was brought up about an Outside Water Use Agreement/Contract. Details about easements, who pays for what portions of installment, meter installment and EDU payments were discussed, Further information is needed to make any decisions at this point.

Nettie Prusinowski has brought to the town a request for a Resolution authorizing Lewis County to apply for 2022-2023 smart growth community planning and zoning grant program funds to advance the preparation and adoption of updated zoning regulations on behalf of the Town of Watson.

<u>Dog Control</u> – Dog Control officer has requested that a warning letter be drawn up so that he can have something to give the individuals that are not complying with the law and getting their dog's registered. The clerk will put it together and contact the dog control officer after.

<u>Water System – Steve</u> has attempted to contact David Wood with no response as of yet, in regards to his water sample. Copenhagen Fire Department accessed a Town of Watson Fire hydrant without permission or notification in which set off a low water level alarm that Steve Skiff was notified of. A bill will be sent to the Village of Copenhagen for the water use \$0.03/gal x 10,000 and \$112.50 for the emergency alarm call. It will be sent this week.

Lead samples have been completed and submitted with no return response as of yet.

Meeting on May 25,2022 in regards to the meter operation issues has resolved the meter issues to this point, will see if all are completed after next read.
